2005 KANSAS CITY BUSINESS ETHICS AWARD

The Kansas City Chapter of the Society of Financial Service Professionals calls for nominations for the 2005 Business Ethics Award program to honor companies that demonstrate a firm commitment to ethical practices in their everyday operations, philosophies and in response to crises and challenges. The Society of Financial Service Professionals is a national organization of 27,000 credentialed insurance and financial service professionals who are active in more than 200 Chapters nationwide.

Nomination Procedures:

Nominations for the 2005 local awards program must be submitted on this form by the deadline listed below. A company may be nominated by a customer, client, employee, consultant, vendor or private citizen who is impressed with the company's ethics program or demonstration of the same. Nominated companies will be notified of their nomination with a copy of the completed nomination form. They will also receive an official Entry Form to complete and submit for consideration to the local program. The entries will be reviewed for the local awards program, and may be forwarded for consideration to the national American Business Ethics Award program, at the Chapter's discretion.

Important deadlines:

Deadline for Nominations	March 1, 2005
Deadline for Entries	May 1, 2005

Finalists will also be forwarded from the local program to the American Business Ethics Award, a nationwide program sponsored by the Society of Financial Service Professionals.


